Inclusion: Willingness to accept and acknowledge diverse ideas, abilities, and self-identifying characteristics.


Innovation: Willingness to seek out and consider different ideas and perspectives.

#### **iPAD INSTALLATION**

The City of Chandler Council has approved and adopted the fiscal year 2022-23 budget, which includes the installation of iPad in our inspection team. To make the smooth transition from the application of laptops to iPad in the field, I reached out to consult with other Building Officials in the neighboring Cities and seek their opinions and suggestions in terms of the operation of iPad utilizing the Accela permitting software system. I appreciated the quick responses and valuable feedbacks received from **Dennis Chase** (Peoria), **Larry Taylor** (Gilbert), **Randy Westacott** (Goodyear), **Stephen Dudley** (Phoenix), **John Sheffer** (Mesa), **Djordje Pavlovic** (Glendale), **Brian Tardif** (Casa Grande), **Brett Harris** (Avondale), **Clayton Trevillyan** (Tucson), etc. A special thanks goes to **John Sheffer**, PE, CBO, Deputy Director/Building Official, City of Mesa, for his great efforts on coordinating a tour for our inspection team to meet with his staff to see how Accela system works on the iPad in Mesa so we can be better off facilitating our transition to using iPad in Chandler in the future.

#### **CROSS TRAINING**

The 2021 new building code cross training program for building inspectors and plans examiners has been conducted in our staff monthly meetings since the beginning of this year. This cross training program not only generates an environment in learning the new code knowledge, but also provides a great opportunity for team members to step up and sharp their public speaking and presentation skills. It is a win-win situation.

From **Ina Ronquillo** on behalf of **Clayton Trevillyan**, **City of Tucson**The City of Tucson launched a new online permitting system, Tucson Development Center Online, on October 31, 2022. The new system provides greater transparency and accountability to the city permitting process while integrating all city departments into the same platform.

After the first month, the system is operating as expected. The current staff focus is initializing legacy permits into the new system while concurrently addressing emergency applications.

New permit applications submitted after October 31 are functioning as expected. Significant staff time is being spent resolving issues related to data migration. Application volume has remained consistent, and staff continues collaborating to reduce review times. The department has dedicated additional resources to handle the increased volume of calls, emails, and over-the-counter inquiries.

PDSD staff has created a <u>Tucson Development Center FAQ</u> offering how-to instructions and videos on essential TDC Online functions. If you have additional questions, you can reach staff by email <u>tdc-online@tucsonaz.gov</u> or phone 520-791-5550.

The City of Tucson would like to thank customers for their continued support and suggestions as we continue to make improvements to the new permitting system.

Yavapai County Development Services received an award. Here is the info that was sent out from our Director Jeremy Dye.

I am pleased to let you know that Development Services has won the Arizona Association of Counties' Summit Award for our "Home of My Own program"! This program was created two years ago to allow for a low-cost option for property owners to build a home using house plans that were designed and preapproved by the County. Those house plans come on one, two, and threebedroom options, and are available for download free to anyone for use in the unincorporated County. To date, we have issued 31 Home of My Own permits with several more in process.
