Self-Introductions & Welcome- Ella Ochoa

Featured topic: "Plan Review for Permit Techs" (based on the 2018 IRC code book)

We welcomed and thanked our guest Ms. Sharon Bonesteel of SRP.



A huge thank you went out Sharon, Tanya Hughes of SRP & SRP for hosting the meeting place, providing a continental breakfast, lunch and snacks. An awesome gift basket was provided for raffle and SRP also had a display booth on hand along with some swag! Everyone in attendance received a NEW 2018-IRC code book!! Thank you Sharon/SRP Building Energy Codes Program!! Tanya Hughes of SRP gave a small presentation on some of the SRP promoted items, such as Energy Efficient LED lightbulbs, thermostats, sun-solar screens, Air filters, etc.

As we all introduced ourselves and our roles in our jobs, it was great to see how much interest is out there that exceeds the role of a permit technician. It was interesting to see how many want to learn and grow further in their positions. A lot of responses that were shared were "I need to understand more of plans", or "I'm dealing more hands- on with plans and "I Need Help"! Sharon's topics included discussions on basic structural items, understanding and knowing how to use the tables in the code, and also navigating the code book, which starts with knowing how the code book is laid out, such as: Effective use of the IRC pages, the Definitions, charts/tables, and appendix pages. Sharon also had great discussion about what a Resilient building would like. Key points that Sharon covered were items such as, protecting against the elements, gravity, resist of the loads, and transfer the loads, seal against penetration of the element. Also items such as design elements, footings, soils (soils reports), roof spans, rafters, calculating tributary areas, load bearing capacities, wind loads (live vs dead), footing details, and post tension/foundations, were amongst many of the items she reviewed with us.

Following along with Sharon was made possible due to the nice gift of all having the same code book to follow, read, flag, and markup as needed, therefore, leaving no one behind. © Sharon encouraged everyone to make time to read the book, cover to cover, as this will improve your value to the department, improve your ability to make more money at our jobs. Her words were: "if you want it, then you will try"!
